INVITATION FOR MARKET CONSULTATION

To properly prepare for the procurement "**Long-term strategy development services for JSC Via Lietuva**", in accordance with Article 27(1)(1) of the Law on Public Procurement of the Republic of Lithuania, joint stock company Via Lietuva (hereinafter referred to as the "Contracting Authority") is conducting a prior market consultation with market participants.

The purpose of the consultation: to inform market participants and other interested parties about the forthcoming procurement before the start of the procurement and to allow market participants and other interested parties to submit comments and proposals about the forthcoming procurement before the start of the procurement.

The consultation documents include a draft technical specification(Lithuanian, English), a draft qualification requirements (Lithuanian, English), a draft Criteria for economic efficiency (Lithuanian, English), contract draft (Lithuanian, English), which shall be published and shall be open for comments and suggestions. A questionnaire for market participants is also attached to which responses are welcome.

The market consultation is not a contract notice or a prior contract notice. The publication of this market consultation does not invite participants to compete for the contract. Participation in the market consultation is gratuitous and does not confer any preferential status for participation in the procurement. No expenses are reimbursed to participants, no compensation is paid, and participation in the market consultation does not affect or give the participant any priority/preference to future procurements or the results thereof.

Method of consultation:

1) The consultation is carried out by means of the Central Public Procurement Information System (hereinafter - CVP IS) in accordance with the procedure established by the Public Procurement Service, asking to provide answers to the questions of the questionnaire, to submit proposals and recommendations, which the Contracting Authority, after evaluating, will decide whether it is appropriate to take them into account during the procurement.

2) Market participants are invited no later than **2025 February 04 1:00 p.m. (in the time of the Republic of Lithuania)**, submit your suggestions and recommendations and answers to the questions of the questionnaire by attaching the questionnaire with the answers to the CVP IS means. **Only one questionnaire needs to be completed (either in Lithuanian or in English).**

3) If necessary, the Contracting Authority may extend the above-mentioned deadlines by publishing a notice in CPV IS.

Informing interested parties: The suppliers' answers to questions or proposals related to the object of the consultation provided by means of the CVP IS are expected to be made public in the CVP IS to the market the market consultation documents no later than before the start of the Procurement.

It should be noted that all documents of this market consultation **are not professionally translated** into English (translation is done using available online tools).
